THE BELOW NAMED COMPLAINANT BEING DULY SWORN, ON INFORMATION AND BELIEF STATES THAT:

Count 1: DISORDERLY CONDUCT

The above-named defendant on or about Tuesday, November 12, 2019, at 3222 North Oakland Avenue, in the City of Milwaukee, Milwaukee County, Wisconsin, while in a public place, did engage in otherwise disorderly conduct, under circumstances in which such conduct tended to cause a disturbance, contrary to sec. 947.01(1), 939.51(3)(b) Wis. Stats.

Upon conviction for this offense, a Class B Misdemeanor, the defendant may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

Probable Cause:

I am a University of Wisconsin-Milwaukee (UWM) Police Officer, and I base this complaint upon the statement of UWM Police Officer Craig Goldsmith, who reports that on the above date, he was dispatched to a call regarding an incident that occurred at the above location. Officer Goldsmith reports that he met with the victim, UWM student, S.B. who reports that she was walking down the 3200 block of Oakland when a man she did not know came up from behind her, wrapped his arms around her knees and picked her up off of the ground. S.B. reports that when she quickly realized that she did not know the person picking her up she began screaming and trying to hit the defendant. S.B. reports that the defendant put her down and began staring at her. S.B. ran across the street, at which time the defendant followed her. S.B. entered Noodles and Company restaurant, at which time the defendant began pacing back and forth outside of the restaurant, at which time S.B. was able to capture video of the defendant on her phone.

Upon arrest, the defendant gave a Mirandized statement on 11-12-19. The defendant stated that he inappropriately touched a student at UWM on said date, close to Noodles. The defendant stated that he did not know the student and that his act was intentional and not a misunderstanding. The defendant stated it was a spontaneous decision, and that he regrets doing it.
